This application constitutes a request for admission to the Speculator Farmers & Crafters Market. Submission of an application does **not** guarantee acceptance. All applications are reviewed by the ASRCC Farmers Market Committee.

This is a **producer-only market**. Vendors must produce 100% of the products offered for sale unless prior written approval is granted by the ASRCC Director.

Applications submitted without full payment and required documentation will not be considered. If an application is not accepted, all fees will be refunded.

SPACE INFORMATION

- Indoor Space: 10' x 10' (limited availability)

- Vendors must supply tables and tents (limited picnic tables indoors)
- Merchandise must remain within the assigned space

Space Preference: Indoor Outdoor

Space assignments are first-come, first-served.

FEES

All ASRCC Members receive three (3) free weeks or \$50 off seasonal rates.

Seasonal Vendor (guaranteed weekly space)

- Single Space (10'x10') – \$200**
- Double Space (20'x10') – \$250**
 - Payment is due with the application
 - Includes one SRCC Facebook promotional post

Weekly Vendor

- Single Space – \$35/week**
- Double Space – \$50/week**
 - Must notify ASRCC by Tuesday of market week
 - Payment is due upon arrival
 - The same space not guaranteed week to week
